FAQs

What is Social Security Disability?

There are two Disability programs:

1. **Supplemental Security Income (SSI)** pays a monthly benefit to people with limited income and resources.
2. **Retirement, Survivors, Disability Insurance (RSDI)** pays a monthly benefit to people (and sometimes certain family members) who have worked long enough and paid Social Security taxes.

What should I do first?

If you have any questions regarding Social Security Disability, we have staff standing by to take phone calls and answer questions. Our hours are 8 a.m. to 4 p.m. CST Monday through Friday. Or visit our website to complete an intake questionnaire and our staff will call you directly.

What is the fee for Disability Specialists' services?

We are only paid if benefits are awarded. The Social Security Administration (SSA) sets the fee for representation. Call to speak to our disability experts for detailed information about SSA's fees or visit our website.

How can Disability Specialists waive fees?

We have partnered with the Department of Human Services to provide our services free of charge for Minnesota residents who receive certain types of assistance from the state. Call us to see if you may qualify.
